Today, physicians interact with industry in the course of medical practice, research, and education. Appropriate interactions with industry can benefit patients, society, and physicians through the advancement of medical science and practice, effective and safe use of health care products and services, and ultimately by improving patients' opportunities to access the benefits of health care and health outcomes. However, physician interactions with industry can enhance their professional judgment and potentially conflict with patients' interests in ways that can harm patients and public health. Evidence indicates that physicians may not always be aware of, or be able to accurately self-assess, how their industry affiliations can unconsciously influence their judgment, their assessment or presentation of medical evidence, their clinical decisions and their prescribing. Physicians have a responsibility to ensure that their participation in collaborative efforts with industry primarily serves the interests of their patients and the public. Physicians must strive first to avoid or second to minimize or manage conflicts of interest. They must always disclose any ties with industry that have, or could be perceived as having, the potential to influence their judgment, including their professional recommendations, clinical decisions, and prescribing. Conflicts of interest arise when a person in a position of trust has competing professional or personal interests. Conflicts of interest occur when judgments or decisions about a primary interest — in this case, patient well-being, trustworthiness, medical research and knowledge, and excellent medical education — are unduly influenced by a secondary interest.
